B. Legislative Update (Rachel London)

Rachel London mentioned that Guy Guzzone is no longer on the Education committee and therefore will probably not seek reappointment upon completion of his term.

C. Summary of Joint Meeting Roundtable Discussion (Mary Leppert, Amy Nicholas, Nancy Vorobey)

Each facilitator for the roundtable discussions provided a summary of their tables discussions. These presentations included the Comprehensive Assessment System (CAS), developmental screening, and the school readiness gap for children with disabilities.

V. ECAC/RTT-ELCG UPDATES: (Roanthi Tsakalas)

In the place of Liz Kelly, who was excused from the meeting, Roanthi Tsakalas provided updates on the race to the Top – Early Learning Challenge Grant (RTT-ELCG). This report included updates on the 939 early learning and development programs are participating in the Maryland EXCELS as of September 13, 2013, representing an increase of 482 programs in the eleven weeks since Maryland's QRIS became available for statewide participation on July 1, 2013. One hundred programs have their ratings published on the website. Programs receiving care subsidies are receiving targeted outreach by mail to encourage their participation in Maryland EXCELS, which will be required by 2015.

VI. MSDE Birth Through Five Updates – (Brian Morrison/Nancy Vorobey)

- B. Dr. Brian Morrison provided the following updates:

 - Revised COMAR regulations went into effect on July 1, 2013; Local programs are required to update policies and procedures by may 15, 2014 to ensure consistency with federal and State regulations.
 - 2. Statewide Data
 - Local profiles and statewide data packets were distributed on October 1, 2013.
 - Improvement Plans and Corrective Action Plans assigned are due on November 1, 2013.

VII. Scenario Focused ICC meeting – The Arundel County ICC Experience (Ed Feinberg)

Dr. Ed Feinberg gave a presentation on a unique Local Interagency Coordinating Council (LICC) meeting that took place in Anne Arundel County. In an effort to help further understand the complexities of their service delivery system, LICC members utilized a case study involving a family with complex needs. Dr. Feinberg reported that the exercise was extremely beneficial for the LICC because not only did each program learn about services that were available in other programs, but also about how much paperwork was involved in enrolling in each program. Dr. Feinberg recommended a more seamless service delivery system that doesn't overwhelm families.
