# **PURPOSE:**

The purpose of this action is to seek adoption of proposed amendments to regulations that will provide "Whistleblower Protection" for local school system employees who report suspected test security violations. (Attachment I)

# **HISTORICAL BACKGROUND:**

The Maryland State Department of Education (MSDE) often receives correspondence from local school system employees wanting to raise concerns regarding suspected testing violations. However, they are hesitant in providing MSDE with details due to fear of some type of reprisal from their school and/or LEA. Without details from these employees, MSDE may not be able to request or conduct a full investigation into test security violations, which may impact the reliability of State assessments. As a result, the State Test Administration and Security Committee proposed adding language regarding "Whistleblower Protection" to COMAR as a means of helping to alleviate some of these fears.

# **SUMMARY:**

On average, each year MSDE receives approximately 10-15 contacts (via telephone, e-mail, letter, fax) with a testing violation concern. Almost always, the contacts wish to remain anonymous. In collecting details of the report, it is often difficult for the details to be offered without the person revealing their identity. Once the contact realizes that he/she cannot remain anonymous, they usually decline to give further information for fear of reprisal from their school and/or LEA.

Currently, COMAR 13A.03.04 Test Administration and Data-Reporting Policies and Procedures addresses test security violations with regards to reporting violations and issuing sanctions. Local school systems are held accountable for reporting any suspected violations. However, there is no mention of protection of employees who wish to report allegations.

The proposed action would add the following new language to COMAR 13A.03.04.07 Sanctions for Violations:

### E. Whistleblower Protection

- (1) The local school system shall not take any personnel action as retaliation against an employee who reports information that the employee reasonably believes involves a test security violation under this chapter.
- (2) The local school system may take personnel action against an employee if the local school system investigates and concludes that the employee was involved in the reported test security violation

Being able to cite "whistleblower" language in COMAR will hopefully allay some of the concerns of those individuals who are aware of suspected test violations and enable these individuals to freely come forth with their reports.

The proposed amendments to regulation were published in the Maryland Register on October 21, 2011. The closing date for receiving public comment o the proposal was November 21, 2011. No comments were received.

# **ACTION:**

I request that you adopt an amendment to COMAR 13A.03.04.07.

# Notice of Proposed Action [11-299-P]

The Administrator of the Motor Vehicle Administration proposes to amend Regulation .01 and adopt new Regulation .08 under COMAR 11.18.02 Self-Insurers.

## Statement of Purpose

The purpose of this action is to amend regulations to clarify to whom the self-insurers regulations pertain and to adopt new regulations to establish procedures for the self-insurance card required for self-insurers. This action is pursuant to H.B. 125, Ch. 320, Acts of 2011.

#### Comparison to Federal Standards

There is no corresponding federal standard to this proposed action.

#### Estimate of Economic Impact

The proposed action has no economic impact.

#### .01 Scope.

These regulations are designed to govern all self-insurers in the State, except [the State government and] the federal government and the State government unless otherwise provided.

#### .08 Self-Insurance Card.

- A. For the purposes of this regulation, self-insurers include:
  - (1) The State Government;
  - (2) Class A self-insurers;
  - (3) Class B self-insurers;
  - (4) Class C self-insurers; and
  - (5) Class D self-insurers.
- B. Upon approval in the program, or a change in the self-insurer's third-party administrator or third party-adjuster, each self-

insurer shall provide the Administration the self-insurer's third-party administrator's or third-party adjuster's:

- (1) Name:
- (2) Address; and
- (3) Telephone number.
- C. The Administration shall provide to self-insurers, in a format determined by the Administration, self-insurance certification for each vehicle upon:
  - (1) Initial registration into the program;
  - (2) Renewal; and
  - (3) Additions to the self-insurer's vehicle fleet.
- D. The self-insurer's insurance card shall include the self-insurer's:
  - (1) Name;
  - (2) Address;
  - (3) Certificate number;
- (4) Self-insurer's third-party administrator's or third-party adjuster's:
  - (a) Name;
  - (b) Address;
  - (c) Telephone number;
  - (5) Vehicle identification number; and
  - (6) Any other relevant information.
  - E. Each self-insurer shall maintain, in each self-insured vehicle:
    - (1) A self-insurance card; or
- (2) Evidence of self-insurance containing the information required by \$D of this regulation, in a format approved by the Administration.
- F. Each self-insurer shall have a 60-day grace period for newly acquired vehicles or vehicles for which there has been a change of self-insurer, allowing time for the Administration to provide the self-insurance card. During that time, for proof of self-insurance, the self-insurers shall maintain a copy of the self-insurer's certificate in the vehicle.

## Notice of Proposed Action

The Maryland State Board of Education proposes to amend Regulation .17 under COMAR 13A.08.01 General Regulations. This action was considered at the August 30, 2011 meeting of the Maryland State Board of Education.

Statement of Purpose

The purpose of this action is to bring COMAR 13A.08.01.17 in compliance with Education Article §7-303, Annotated Code of Maryland.

Comparison to Federal Standards

There is no corresponding federal standard to this proposed action.

**Estimate of Economic Impact** 

I. Summary of Economic Impact. Local governments may experience economic impact through their local school systems. The regulation requires each public school that enrolls students in grades 6 through 12 to designate at least one school security officer. If the security officer is a school staff member, then part of that person's time would be taken from the person's normal duties to attend to the added responsibilities of the security officer. Additionally, that person would have to receive specific training pertinent to the position's duties and its responsibilities related to the gang policy's implementation. If the school security officer is to be an actual School Resource Officer, then designated schools without a School Resource Officer would have to arrange with the local law enforcement agency to employ such an officer. The regulation also requires the removal of a student who is convicted or adjudicated delinquent for an arrest involving rape or a sexual offense to another school and/or bus other than the victim's. There may well be an unexpected cost to regularly transport this student to another school. Additionally, a few of the smaller school systems only have one high school or have a longer distance between schools. This requirement, in addition to fiscal impact, would place an inordinate burden on such a school system to have to provide appropriate educational programming for the convicted/adjudicated student.
