
APPENDIX A: THE 2010 MSA-READING STRATIFIED RANDOM SAMPLING

Since reporting deadlines made it difficult to use the Maryland school population as calibration and equating data set, Pearson used to use equating samples instead of the population. For this year, however, Pearson was able to use 99% of the whole population for grades 6 and 7 equating. Therefore, stratified random sampling was conducted for only grades, 3, 4, 5, and 8.

Pearson chose Local Education Agency (LEA) as one of the most important variables for stratification. Based on the population percentage of each LEA, Pearson randomly selected about 3,000 students for those grades from first-waved documents (i.e., 50% of the statewide population) which were randomly distributed and completely scored. It should be noted that this method has been applied since the 2006 assessment.

To verify that the sample was representative of the statewide examinee population in terms of gender and ethnicity, the distributions of gender and ethnicity of the 2010 samples were compared with the 2010 population. The results are shown in this Appendix. The percentages of students from the LEAs were all within 3 percentage points of the target values across all grades. The percentages of students from the five major ethnic groups were all within 7 percentage points of the target values across all grades. The percentages of male and female students were within 1 percentage points of the target values across all grades. Consequently, we concluded that the 2010 equating samples were representative of the 2010 statewide examinee population in terms of LEA, gender, and ethnicity.
