Elenilson Ayala [Bladensburg Elementary School, Prince George's County Public Schools]

- Elenilson Ayala has been a parent involvement volunteer at Bladensburg Elementary School for the past 8 years. Seeing the need for parents to be more involved in their children's education and in the school, he took the lead by running for Treasurer on the PTA Board. He was also very instrumental in rallying parents and community members in creating some of the most successful celebrations the school has performed. The Hispanic Heritage Celebration boasted a standing room only crowd with foods being supplied by the parents and the community - it has become an event that families of <u>all</u> cultures look forward to attending. After having regular dialogue with the administration and parent liaison at the school, he realized that there was a need to try to increase the Hispanic parent involvement – many parents did not participate in school-related events or parent conferences due to their language barrier. Mr. Ayala volunteers to translate in PTA meetings, parent workshops, and conferences. Because of his tireless efforts, a tutoring service assisted over two hundred students in the summer months; this helped to keep the students off of the streets and more importantly, strengthened their reading and math skills. Mr. Ayala's dedication and passion for children and getting parents involved, has translated in more involvement from all of the parents and several community businesses.

Mary Baskar [Baltimore County Public Schools System]

- Mary Baskar serves as chairperson for the Baltimore County Public Schools Special Education Citizens' Advisory Committee (SECAC); her position affects all schools throughout the Baltimore County Public School System. Her commitment to this position requires many volunteer hours to support the education of children with disabilities. In 2007, Mary initiated an inclusive summer camp program, which resulted in the inclusion of children with disabilities with their typically developing peers in an Extended School Year (ESY) program. Her leadership resulted in the collaboration of parents and Baltimore County Public School staff in the start-up of "Camp Honeybee."

Dawn Branch [Bay View Elementary School, Cecil County Public Schools]

Anita Brown [Robert Goddard Montessori School (RGMS), Prince George's County Public Schools]

- To say that Anita Brown is a valuable asset to RGMS, students, parents, and the community at large, is an understatement. Mr. Brown attends all Back-to-School night events, senior portfolio interviews, sports season informational meetings, and various service learning events in an effort to promote the importance of parent involvement. In addition, he can be found working concessions during sporting events, collecting canned food for the food drives sponsored by the Student Government Association, volunteering as a school safety monitor, organizing membership drives for the PTSO, and cheering on the "Westlake Wolverines" at home **and** away games.

Chad Chitvaranund [Burtonsville Elementary School, Montgomery County Public Schools]

- Chad Chitvaranund has been PTA President for three years, and is a gift to the children, parents, and staff at Burtonsville Elementary School. Joyce Murphy [Plum Point Middle School, Calvert Count Public Schools]

- Joyce Murphy is a valuable asset to the PTSA's Hospitality Team at Plum Point Middle School. From her many hours of volunteerism on School Beautification Day to her work at the school's book fairs, she strives for perfection in leadership and it shows in everything she does. His leadership has fostered greater volunteer involvement at Montgomery Blair High School; helped preserve and adapt existing school resources to the benefit of the community; promoted the arts for young actors and musicians; and incorporated the use of emerging technology to bring a sense of community to the schools, just to name a few. While serving as a PTSA Co-President, Mr. Ottalini was instrumental in starting a Drama Boosters Club and was personally involved in everything from publicity, to taking performance photos and video. In every school his children have attended, he has arranged classroom computer donations, in addition to volunteering in the classrooms regularly, and spearheading PTA mini-grant programs.

Gloria Parker [Worcester Technical High School, Worcester County Public Schools]

- Gloria Parker is a role model for parent involvement and community support of education. Ms. Parker's efforts in communicating her vision of providing **all** students the opportunity to prepare for college and a career in the community, at Career and Technology Task Force meetings, and the Worcester Technical High School Improvement Advisory Committee (SIAC) have contributed to not only a new building, several new programs of study (including pre-engineering, early childhood education, and firefighting), but a new interest in technical studies in Worcester County. Ms. Parker is Worcester Technical High School's team mom. She promotes the school motto "Teach the Whole Student."

April Payne [Snow Hill Middle School, Worcester County Public Schools]

- When April Payne's son was at Snow Hill Elementary School, our feeder school, she served as an officer on the PTA and as a member of the School Improvement Advisory Committee. At Snow Hill Middle School, she remains active in the PTA and acts as a conduit between parents and the school, informing and answering questions related to programmatic and fiscal issues. She has worked tirelessly to raise funds for an updated school playground – a process that spanned over several years and involved community awareness and fundraising. She has also worked with local community agencies to obtain funding for a school sign to keep the public informed about upcoming school events.

Vanessa Pinto [New Hampshire Estates Elementary School, Montgomery County Public Schools]

- Vanessa Pinto is an integral part of the School Leadership Team helping educate staff about the Latino community perspective on academics. She frequently volunteers her time and skills in the classroom as well as to the entire school. She serves both on the School Leadership Team and Parent Involvement Committee; attends all PTA functions and Family Learning Nights; participates in the weekly parent coffee and recruits other parents to attend; and often serves as a language interpreter. Staff and students at New Hampshire Estates Elementary School have benefitted from her advocacy by being more sensitive to the cultural and linguistic backgrounds of families. In addition, families have benefitted by having materials better suited to their needs. Ms. Pinto is a proven leader among parents and is driven by a desire to see more parent involvement, particularly among the Latino population.

Sandy Rooney [Mechanicsville Elementary School, St. Mary's County Public Schools]

- Sandy Rooney has been an active parent volunteer at Mechanicsville Elementary School for the past four years. Ms. Rooney serves as chairman of the PSTO Craft Club and implemented the Craft Club, an after-school, hands-on activity for kindergarten and 1st grade students. Ms. Rooney is also Secret Santa Shop Chairman, a three-day event in which each homeroom is given a specific time to buy gifts for their family members, including pets. Ms. Rooney volunteers her time for the PSTO Family Fun Nights, and the Box Tops Program, which as a positive financial impact on the entire school community. Through her leadership and organizational skills, Mechanicsville's school programs are alive and thriving.

Michelle Schachter [Showell Elementary School , Worcester County Public Schools]

- Michelle Schachter has been the Autistic Children's Support Group President in Worcester County for over three years. She has spearheaded efforts to provide schools in Worcester County with materials, training, and monetary support to help improve the education of students with autism. In 2006, Ms. Schachter organized "Ride for Awareness", where participants raised money for kids by completing a spinning class. In addition to all of her work with the Autistic Children's Support Group, she also finds time to be part of the county's Special Education Citizen Advisory Board. She balances the needs of her own children, and the needs of other parent and students with disabled children, by communicating ideas and concerns in a sensitive and constructive way. As Vice President of the Special Education Citizens Advisory Committee (SECAC) Ms. Schachter has assisted families in finding the resources, funding, and support for their special needs children. Her dedication has made a difference for parents, teachers, and children alike.

Amber Schaefer [Elmwood Elementary School, Baltimore City Public Schools]

- Amber Schaefer has had a significant, positive impact on public education with her creativity, innovation, and commitment. As PTA President and through her efforts, parent involvement has increased in school-wide book fairs, fundraising events involving local restaurants, and a Dinner with Santa event. In addition to her school contributions, she leads an open meeting each month with the community, and diplomatically addresses concerns. She has collaborated with the school community to organize a toy drive for the children of University of Maryland Pediatric Oncology Unit so that each child in that unit receives a gift for the holiday season. Ms. Schaefer has resurrected an almost extinct PTA to a group that is supportive and successful in reaching their goals for the school. In addition, Ms. Schaefer has been a scouting volunteer for eight years – both Girl Scouts and Boy Scouts. She believes in the welfare of children and wants all children to succeed in today's changing world.

Stephanie Simms [Patterson Park Public Charter School, Baltimore City Public Schools]

- Stephanie Simms outstanding contributions to Patterson Park Public Charter School (PPPCS) span from her serving as a member of the school's Board of Directors to serving as a volunteer in the school's cafeteria. Ms. Simms is a Co-Chair of the Action Collaboration Team (ACT), which is the action arm of the school's improvement plan. In this role, she organizes and reinforces academic interventions and activities that enhance the learning of all students. In addition, she is Uniform Committee Chair, whose purpose is to create uniform policies and procedures for the school. Ms. Simms spearheaded the planning and coordination of the school's kindergarten picnic, as well as takes key roles in both planning the school's Open House and giving tours to prospective families. Furthermore, she volunteers at the Scholastic Book Fair, assists students during physical education classes, and chaperones an after-school activity at Port Discovery in Baltimore and field trips.

Vanessa Singletary [Franklin Square Elementary Middle School, Baltimore City Public Schools]

- Vanessa Singletary is a dedicated grandparent volunteer and PTA President. Ms. Singletary was one of 25 participants selected, out of over 100 applicants, to participate in the Baltimore City Public Schools Systems Parent Leadership Institute (PLI). Under her exemplary leadership, the school has established a functioning parent room. She has solicited outside resources for parent workshops, organized an 8-week nutrition class for parents to learn about shopping, cooking, and healthy eating. Ms. Singletary has sought resources and grant funding to hold monthly community nutrition classes for parents and the community. Ms. Singleton has said "Kids can light up your day!"

Carol Smalls [Montgomery Blair High School, Montgomery County Public Schools]

- Carol Smalls spearheaded educating the school staff about the grocery store fund raising programs in the Blair community. Through her tireless efforts to advertise, collect, and tabulate an unimaginable number of receipts submitted by families from local supermarkets, Ms. Smalls was able to raise over \$10K which was distributed to programs through the school's mini-grant programs, the After-Prom celebration, and new academy programs. For two consecutive years, these funds have helped double the value of the mini-grant awards the PTSA could award and allowed the PTSA make a year-end gift of \$1K to each of the school's five academies to promote their programs. Montgomery Blair is not the only school where Ms. Smalls has worked her magic - as her children transitioned, so did she – she also tracks receipts at Piney Branch Elementary, Takoma Middle, and Northwood High Schools – raising more than \$4K through the eScrip program for one school.

Dawn Smith [Grasonville Elementary School, Queen Anne's County Public Schools]

- Dawn Smith is a parent who has made a conscious decision to dedicate her volunteer efforts at Grasonville Elementary School to a subject area for which she is passionate – mathematics enrichment. Ms. Smith holds a Bachelor of Science Degree from the University of Maryland in Finance, and has been an advocate for challenging them to incorporate an enrichment math program for the students. Her challenge was not only a call to action for the community, but she rolled up her sleeves to help to build such a program. From this passion came the Math Enrichment Program. Ms. Smith has been involved at every step in the process, developing and implementing this enrichment experience. The Math Enrichment Program is based upon utilizing the *PROJECT M*₃: *Mentoring Mathematical Minds* format, which is designed to help children increase their ability to communicate mathematicians and become better problem solvers. In addition, she shares her expertise as a parent volunteer with the Grasonville Engineering Club. Her dedication to expanding students knowledge-base by promoting the Math Enrichment Program; her contagious passion for all things mathematical; and her caring spirit have certainly proven to be an asset to <u>all</u> students of Grasonville Elementary School.

Rachel Sorrell [Bester Elementary School , Washington County Public Schools]

- Rachel Sorrell has been a multi-faceted parent volunteer at Bester Elementary School for more than six years. Ms. Sorrell is a working single-parent who has contributed any spare time to volunteering for the Bester Boosters, Inc., the PTA, as well as the NAA Accreditation of the YMCA Bester Afterschool Program. The NAA Accreditation process at the Bester Afterschool Program was in need of restructuring, which Ms. Sorrell played a vital role in to help give quality affordable child care to Bester Elementary families. In addition to her contributions to a variety of school organizations, Ms. Sorrell spends her days off volunteering in her daughter's classroom, and other classrooms when necessary. She is dependable, self-motivated, productive, and punctual. She is truly a valuable asset to the school through her commitment to education, dedication, and countless hours of volunteering.

Glenda Stalnaker [South Carroll High School, Carroll County Public Schools]

- Glenda "Sam" Stalnaker started the PTSA at South Carroll High School. The PTSA makes is possible for all of the school's stakeholders to take an active part in educating students. She is instrumental in the implementation of a strong volunteer program that provides continuous support through their participation on school committees, with extra-curricular activities, organizating fundraisers, assisting individual teachers, and sharing information about the school to the community. Her effective communication skills invite parent cooperation and participation. Her ability to collaborate effectively with administrators, staff and other parent groups are also contributing factors to her success as a school-based Volunteer Program coordinator and trainer at South Carroll High School.

Nicole Stewart [Robert Goddard Montessori School (RGMS), Prince George's County Public Schools]

- Nicole Stewart volunteers countless hours at RGMS as PTSA President, a sponsor of after-school student projects, as School Planning and Management Team Parent Representative, and as a leading figure in establishing a parent education program, "Montessori University" – which sponsors quarterly parent education workshops. Since its inception in 2008, over 350 parents have attended at least one Montessori University event. In addition, the school campus is landscaped with flower-lined courtyards and has well-maintained play areas due in large part to Ms. Stewart's efforts to motivate our staff and community to beautify our campus. Ms. Stewart frequently volunteers in her daughter's classroom and works with all the students. She remains in the forefront of fundraising endeavors that enable the school to meet the needs of all students.

Paula Todd [Crisfield Academy and High School , Somerset County Public Schools]

- Paula Todd is not only dedicated to her children, but the community as a whole. She has been involved in tutoring students, chaperoning dances, school trips, picnics, grading papers for teachers, volunteering at book fairs, and contacting civic groups, local businesses, and organizations to raise money so students could sing at the White House – this included paying for charter buses, meals, and making sure that every child had the proper clothing to honorably represent Somerset County Public Schools. Ms. Todd exemplifies the true spirit of volunteerism.

Pamela Toomey [Annapolis High School , Anne Arundel County Public Schools]

- Pamela Toomey's dedication has played a vital role in Annapolis High School's (AHS) success and making Adequate Yearly Progress (AYP). Countless students and adults have benefitted from the many hours she spends making students feel safe and supported. In addition to being a PTSA member and working with the graduation committee, she is also a member of the Incentive Committee for Positive Behavior Interventions and Support (PBIS) Team. In her role with PBIS, she is responsible for organizing and providing incentives for teacher and students on a weekly basis. Ms. Toomey was very instrumental in the planning and opening of the school store, The Panther Den, and The Panther Café. The Panther Café is a safe, supervised place where students and adults can visit after school to de-stress, study, and have fun.

Thomas Tyndall, III [Buckingham Elementary School , Worcester County Public Schools]

- Thomas Tyndell's has diligently served on the School Improvement Advisory Committee and Buckingham Elementary School Planning Council for several years. He advises administration and other schools leaders on parent and community concerns – he is a valuable liaison between the school, board of education, parents and community. Mr. Tyndall played a vital role in helping Buckingham Elementary School to gain accreditation. In addition, he has made job-related presentations to second grade students to give them a hands-on approach to the electricity science unit, and has served as a chaperone on several occasions. Mr. Tyndall embraces the school's motto, "Together for Success" through his unwavering support.

Roxanne Tucker [William Wirt Middle School, Prince George's County Public Schools]

- Roxanne Tucker currently serves as Vice-President of the PTSA which sponsors a multi-cultural dance; Harvest Fair; and a health fair for the families in the community. Ms. Tucker also assists in the Parent Resource Room; she completed the Parent Assisting Teachers Program, which enables her to assist in the classroom and to provide clerical assistance in the main office. Ms. Tucker offers valuable insight to the School Compact and Parent Involvement Policy. She is truly an asset to William Wirt staff and students as well as the community.

Rhonda Ulmer [Van Bokkelen Elementary School, Anne Arundel County Public Schools]

Kathy Wool [Snow Hill High School, Worcester County Public Schools]

- Kathy Wool, the parent of Snow Hill High School students, has dedicated herself to helping students live healthier lives. As a dietician for the Worcester County Health Department, she has seen the devastating impact of health-related illnesses such as obesity, diabetes, and hypertension. Without hesitation, Ms. Wool volunteered to organize and teach a class during after-school hours that would focus on healthy lifestyles and nutrition. Not only did she teach the class, she recruited others to help her with the physical fitness component. The result was a 12-week course open to all Snow Hill High School students. The class met once a week and included a discussion, food preparation demonstration, and a period of movement and flexibility exercise. In addition, Ms. Wool is a member of the School Improvement Advisory Committee (SIAC). This committee of stakeholders is established to evaluate and maintain methods to improve the operation, climate and community relations of the school. Because of the public speaking requirement of this position, volunteer to carry out this task are few and far between. Ms. Wool flawlessly presents the school's budget proposal to both the Worcester County Board of Education and the Worcester County Commissioners. Her cooperation, philanthropy, and time are greatly appreciated by the students, staff, and community of Snow Hill High School.

Allene Wyatt [John Hanson French Immersion Elementary/Middle School, Prince George's County Public Schools]

- For well over 6 years, Allene Wyatt has worked tirelessly on the French Immersion Program at the school. She has advocated before the PGCPS Board for a French-speaking principal; certified French-speaking teachers, French classroom instructional materials, as well as renovation of the 50 year old school house. Ms. Wyatt has had many accomplishments including the school's Annual "La Fete de la Francophonie" event which recognizes and celebrates the French language spoken around the world. Since its inception, the event has attracted more than 1,200 attendees who gather to witness K-8 students and teachers perform songs, dances and skits from the French Diaspora. Parents, school, embassy and county government officials, and dignitaries representing Francophonie counties sample culinary delights representing a variety of French-speaking counties. Through her efforts, more than \$12K in grants and donations has been secured to allow the school to host this event free of charge to all attendees. Her ability to raise funds and solicit community businesses and organizations for support is truly an asset.
