NOTICE OF NON-COMPLIANCE WITH MAINTENANCE OF EFFORT

Dear Mr. Pollitt:

On November 15, 2011, the Superintendent of Wicomico County Public Schools, Dr. John Fredericksen, filed a Maintenance of Effort Certification Statement (Attached) with the Maryland State Department of Education. Pursuant to Education Article §5-213 and based on the dollar amounts reflected on the certificate, I find that Wicomico County is not in compliance with its FY 2012 maintenance of effort requirement. Specifically, because Wicomico County was granted a waiver of the FY 2011 Maintenance of Effort requirements by the State Board of Education, the FY 2012 requirement is based on the greater of FY 2010 or FY 2011 per pupil local appropriation. Therefore, the maintenance of effort level amount for FY 2012 is \$50,126,691. Wicomico County failed to meet that target. Dr. Fredericksen has certified that the net local appropriation was \$36,196,892.

If the county disputes this finding of noncompliance, it may send to me within 30 days of the issuance of this notice of memorandum setting forth the basis for disputing this finding. I will refer the matter to the State Board of Education which will make the final determination.
