#### CHILD FIND 34 C.F.R. §300.131

Each local school system shall locate, identify, and evaluate:

- □ All private school students with disabilities enrolled in a private school–including religious school students– within the jurisdiction of the local school system
- At no cost <u>and</u> not considered as part of the proportionate share
- Includes out-of-state students attending private schools within the jurisdiction of the local school system

### CHILD FIND DESIGN 34 C.F.R. §300.131(b)

- Equitable participation
- Accurate count of <u>all</u> students identified as students with disabilities under IDEA

### CHILD FIND DESIGN 34 C.F.R. §300.131(c)

Comparable child find activities:

- Public Awareness
- Determination of eligibility as a student with a disability under IDEA (Evaluation)

Determination of continued eligibility (Reevaluation)





### CONSULTATION 34 C.F.R. §300.134

Consult with private school representatives and representatives of parents of parentally placed private school students with disabilities.

- Child Find
- Proportionate Share of Funds
- Consultation Process
- Provision of Special Education and Related Services
- Written explanation

#### Preschool Students, Ages 3 through 5 34 C.F.R. §300.133(a)(2)(ii)

Parentally Placed Private School Students with Disabilities

Children aged 3 through 5 are considered to be parentally-placed private school students with disabilities enrolled by their parents in private schools-including religious elementary schools-if they are enrolled in a private school that meets the definition of an elementary school under Maryland law.

Parentally Placed Private School Students with Disabilities

- Services provided to parentally placed private school students with disabilities must be provided by personnel meeting the same standards as personnel providing such services to students with disabilities in public schools
- Exception-private school teachers providing equitable services are not required to meet the highly qualified special education teacher requirements.

## Provision of Equitable Services 34 C.F.R. §300.138(c)

- Employees of a public agency; or
- Through contract with a public agency

Parentally Placed Private School Students with Disabilities


 Special education and related services, including materials and equipment must be secular, neutral, and nonideological

### Location of Services 34 C.F.R. §300.139

- Services may be provided on-site at the student's private school, including a religious school, or at another location
- Transportation
  - If necessary to enable the student to benefit from or participate in the services provided
  - Cost of transportation may be included in calculating whether a school system has expended a proportionate share of IDEA Part B funds

### Annual Count 34 C.F.R. §300.133(c)

- Last Friday of October, annually
- <u>All</u> parentally placed students with disabilities enrolled in private schools within the jurisdiction of the local school system:
  - Children served
  - Children not served but eligible

#### Record Keeping 34 C.F.R. §300.132(c)

- Number of children evaluated
- Number of children determined to be children with disabilities
- □ Number of children served

- Maintenance and Use of Data
  - Accurate Count
