## Introduction

Annually, on December 1, the Maryland State Department of Education (MSDE) collects information on students with disabilities (ages 3-21) who reside in the State of Maryland. In order to be included in this count, the child must be identified as having a disability and receiving active special education services on December 1.

The Special Services Information System (SSIS) consists of two separate data collections. The first is the December 1 Census, a count of all students receiving special education services on December 1 of every year. Data on students who have exited special education are collected on June 30 of every year.

The SSIS database is used to compile information on Maryland students with disabilities. MSDE uses the SSIS database as:

- a source of information to meet its planning, monitoring, and accounting responsibilities for special education;

- a recording and reporting tool for decisions made by the Individualized Education Program (IEP) Team; and

- an instrument for federal reporting requirements.\*

### Highlights

The data that follow were collected from all public agencies, including Maryland School for the Deaf and Maryland School for the Blind. This census serves as a point in time snapshot of special education students on December 1, 1999.

Students with disabilities make up 13% of the total public school enrollment (September 30, 1999 Enrollment Data). In 1994, students with disabilities made up 12.6% of the total enrollment. In 1989 students with disabilities made up 12.5% of the total enrollment.

The public agencies with the largest percent of students with disabilities are Baltimore City and Allegany County. Students with disabilities make up 17.1% of the total enrollment in Baltimore City, Allegany 16.7%. Prince George=s and Howard Counties have the smallest percent of students with disabilities, each reporting approximately 10%. See Table 12 on page 14.

Students with specific learning disabilities are the largest percent of students with disabilities, 40.7%, followed by speech and language impairments, 27.7%. Students identified as deaf/blind are the smallest percent of students with disabilities, .02%. A Pilot Program for identifying children ages three through five with developmental delay has been implemented. As of December 1, 1999 14 counties are participating in this program.

The majority (45%) of students with disabilities are served in regular classrooms, followed by separate classrooms(24%) and resource rooms(21%). See Table 7 on page 8.

### Definitions

#### Least Restrictive Environments

**General Education Classroom** - students with disabilities enrolled in a comprehensive school who receive special education and related services *outside the general education classroom* for less than 21% of the school day. Preschool includes any combination of regular early childhood setting with no pull-out, e.g., EEEP, Headstart, or other early childhood settings.

\*Required by the Individuals with Disabilities Education Act (IDEA), as ammended June 4, 1997 (PL 105-17) as well as reporting requirements for Title VI and Title IX of the Civil Rights Act, as the Titles apply to Special Education, and Section 504 of the Rehabilitation Act of 1973.

**Resource Room/Combined Program** - students with disabilities enrolled in a comprehensive school who receive special education and related services *outside the general education classroom* for at least 21%, but no more than 60% of the school day. Preschool includes pull-out programs.

**Separate Class** - students with disabilities enrolled in a comprehensive school who receive special education and related services *outside the general education classroom* for more than 60% of the school day. Preschool includes separate class in school or private child care facility.

**Homebound Placement** - students with disabilities who receive greater than 50% of instruction homebound.

**Hospital Placement** - students with disabilities who receive greater than 50% of instruction in a hospital setting.

**Public Separate Day School** - students with disabilities who spend greater than 50% of the school day in separate public facilities as day students.

**Private Separate Day School** - students with disabilities who spend greater than

50% of the school day in separate private facilities as day students.

**Public Residential Facility** - public residential placement for students with disabilities.

**Private Residential Facility or Center** - private residential placement for students with disabilities.

### **Additional Preschool Least Restrictive Environments**

**Home** - preschoolers with disabilities for whom it is appropriate to receive services at home, not single service.

**Itinerant Setting** - preschoolers with disabilities who receive only speech and/or language at a school or another location.

**Reverse Mainstreaming** - preschoolers with disabilities who receive special education in a class designed for students with disabilities where over 50% of the students are not disabled.

December 1, 1999

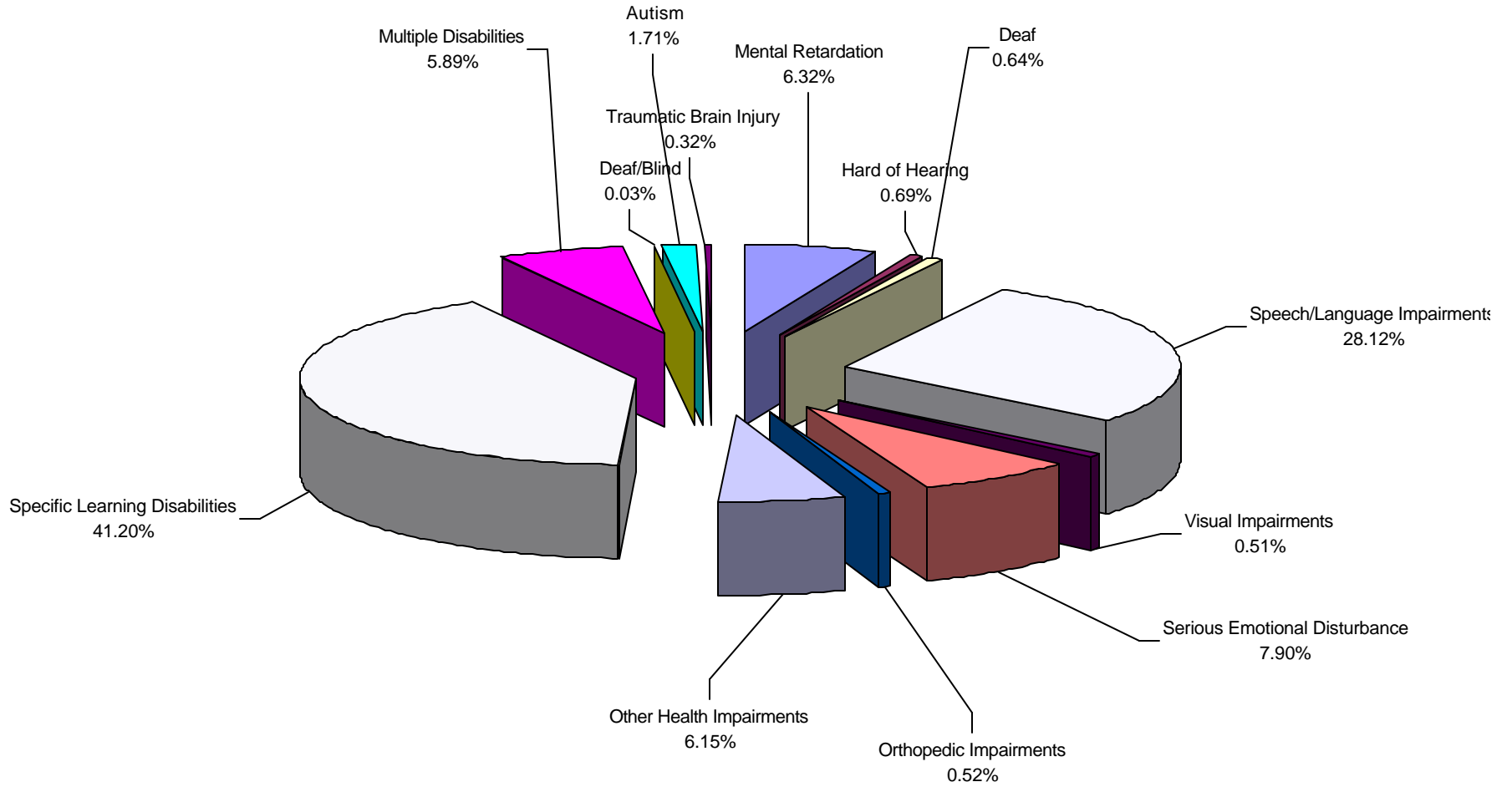

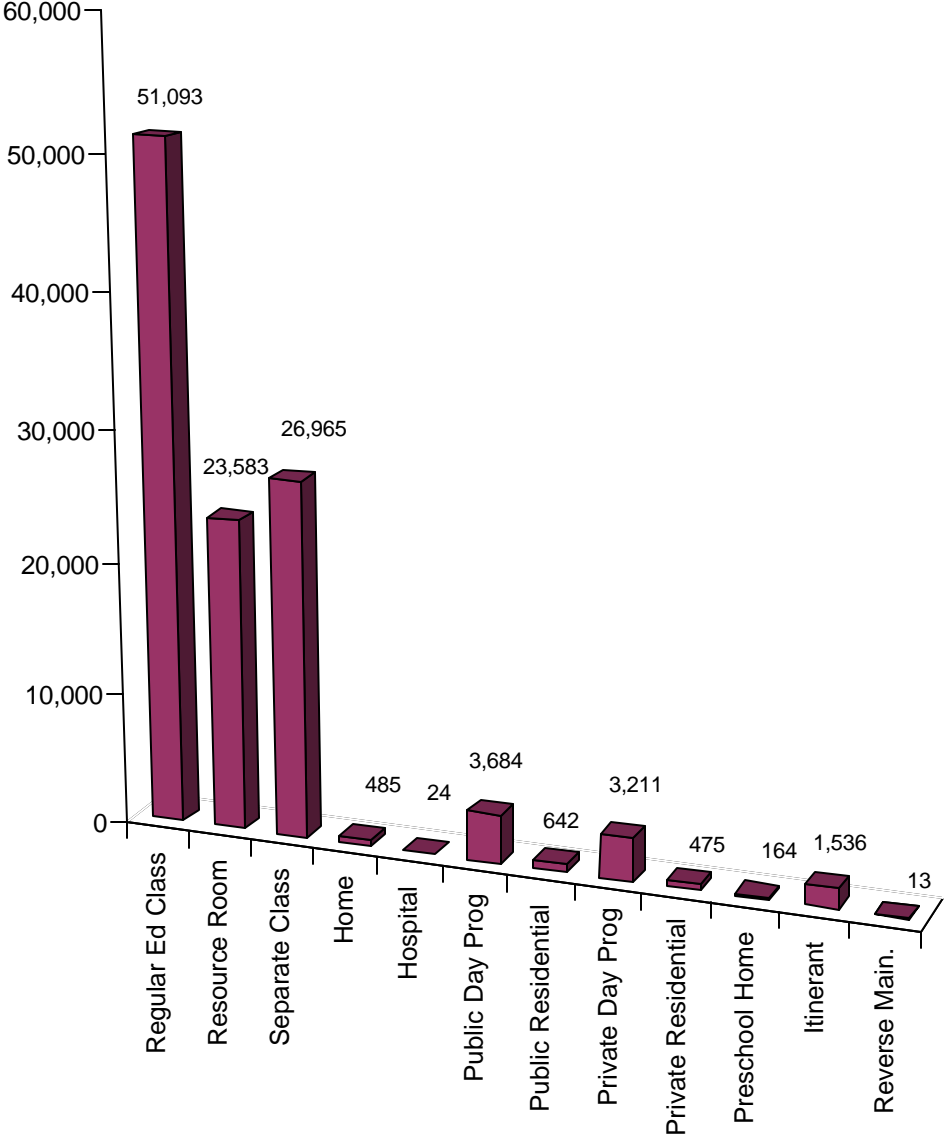
