Introduction

This report contains data on the number of suspension incidents in each local school system and school during the 2011-12 school year. The data have been disaggregated by gender and race. The counts of suspension and expulsion incidents for students with disabilities are also reported. Student offense data are available for reporting by Out-of-School Suspensions and Expulsions, In-School Suspensions, and Combined In-School and Out-of-School Suspensions and Expulsions.

Each offense has been categorized into eight major categories. The following list shows which offenses are included in each major category. Definitions of the offenses are described in the *Maryland Student Records System Manual, 2011*
