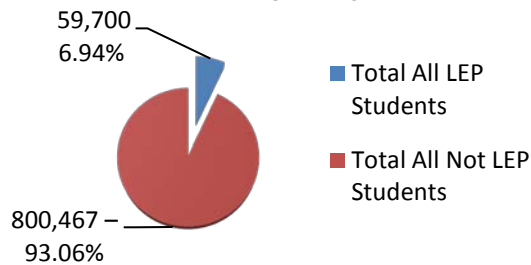

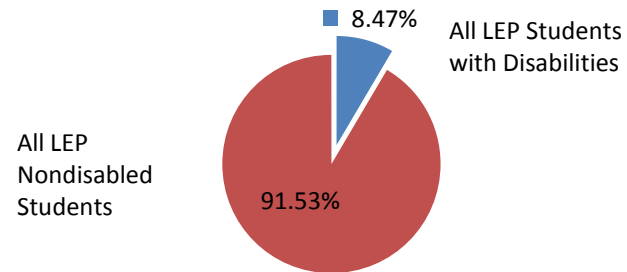

# All Students Compared to Students with Disabilities with Limited English Proficiency (LEP)

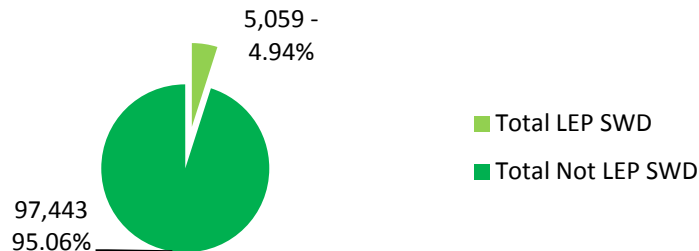
## All Students Disaggregated by Limited English Proficiency (LEP)



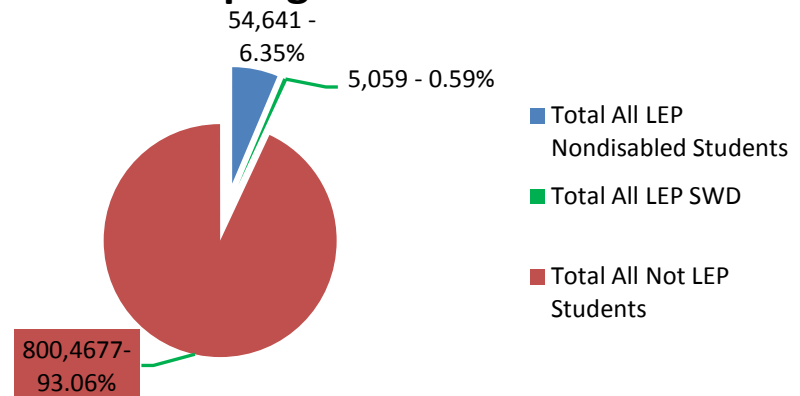
## LEP Students with Disabilities (SWD) to All LEP Students



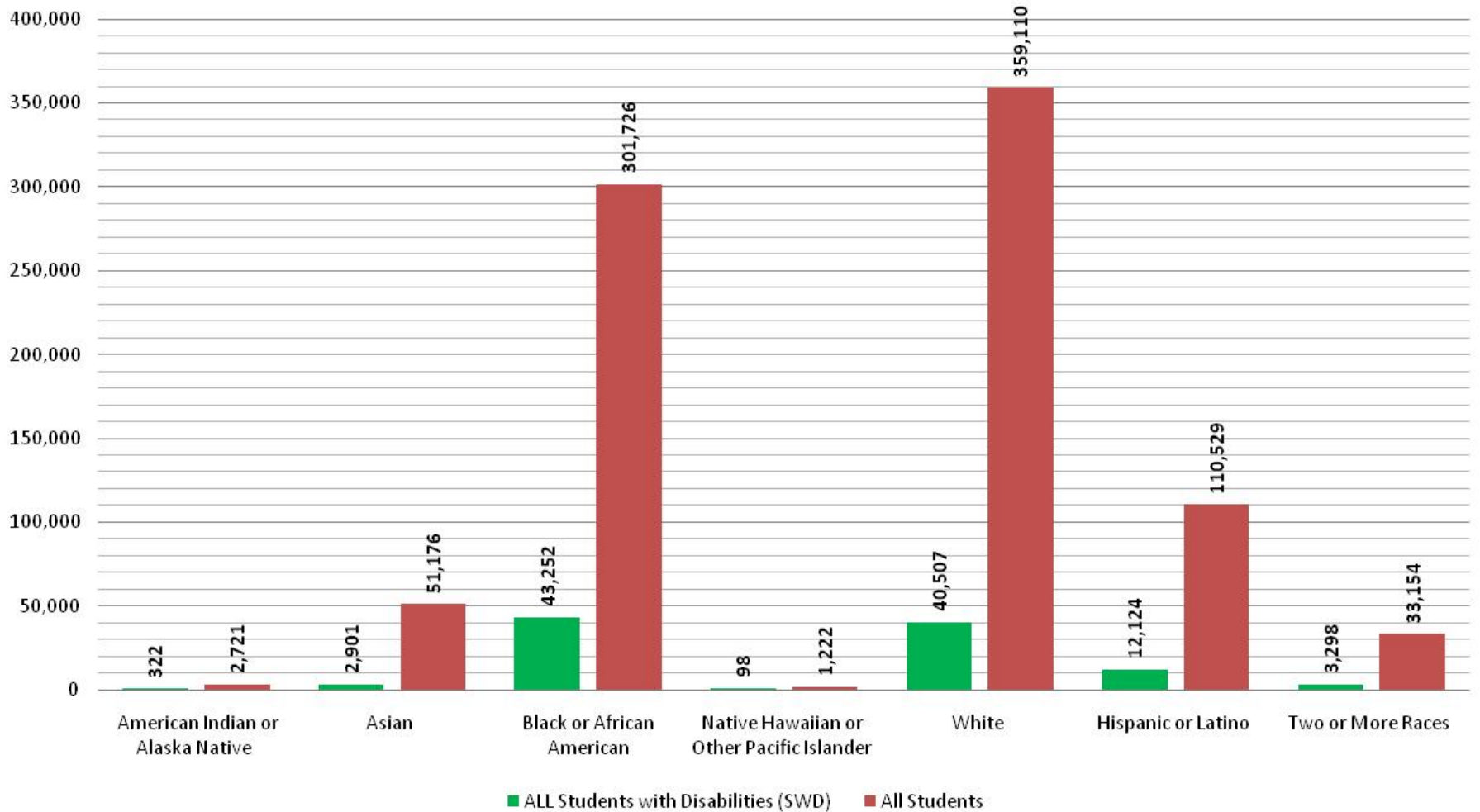
## Students With Disabilities (SWD) Disaggregated by (LEP)



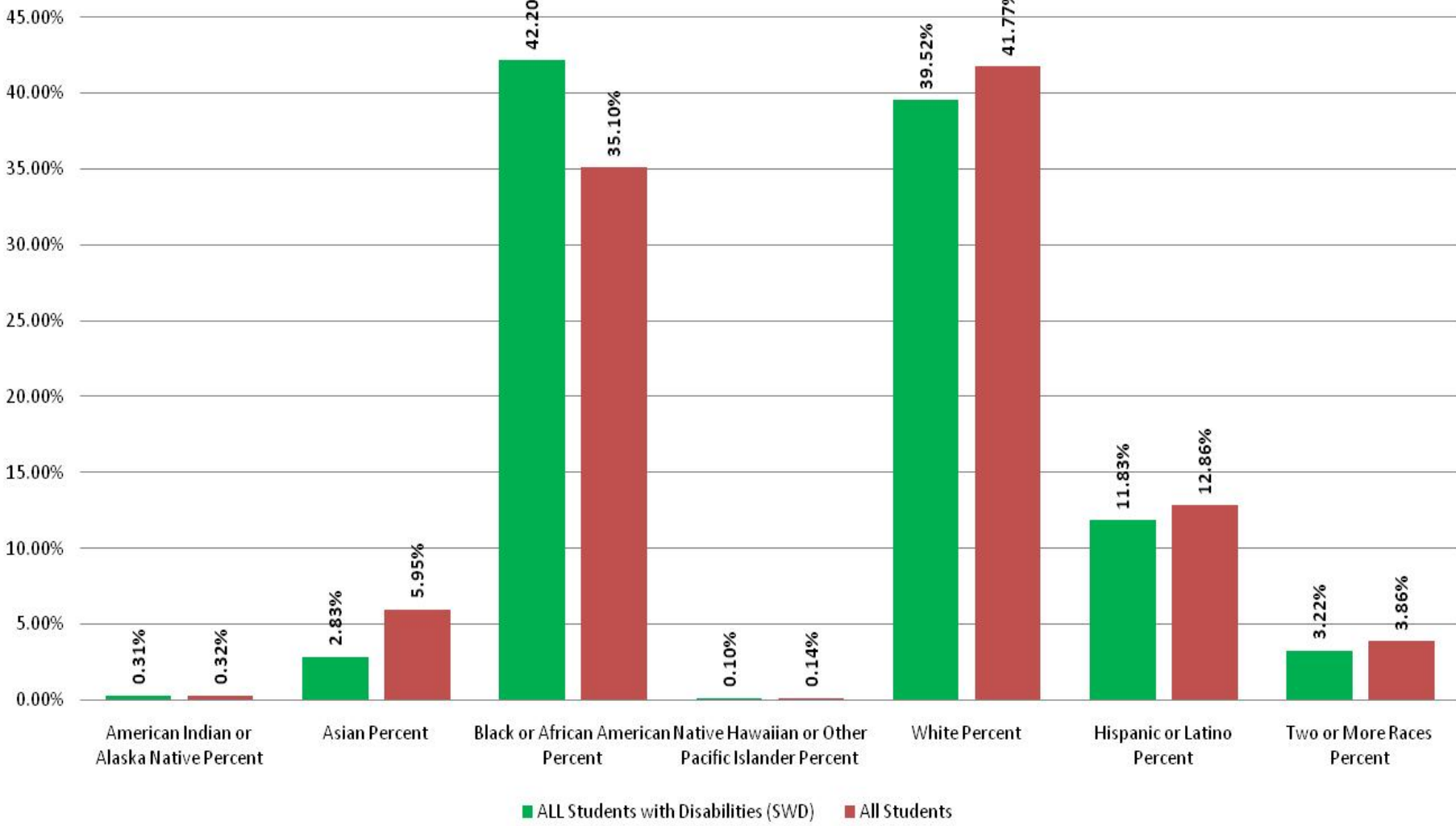
## All Students including Sub-Groupings for LEP & SWD



## All Students Compared to Students with Disabilities by Race Ages 3-21

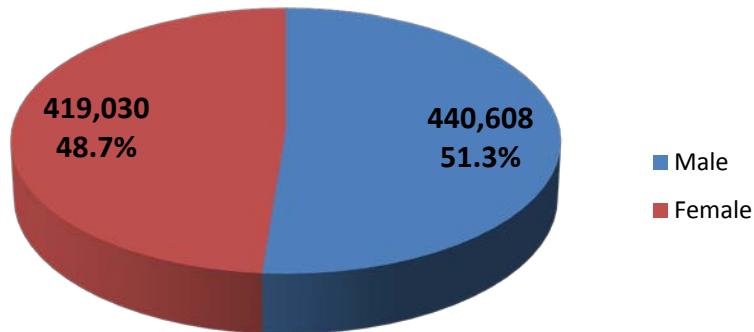


# All Students Compared to Students with Disabilities by Race Ages 3-21

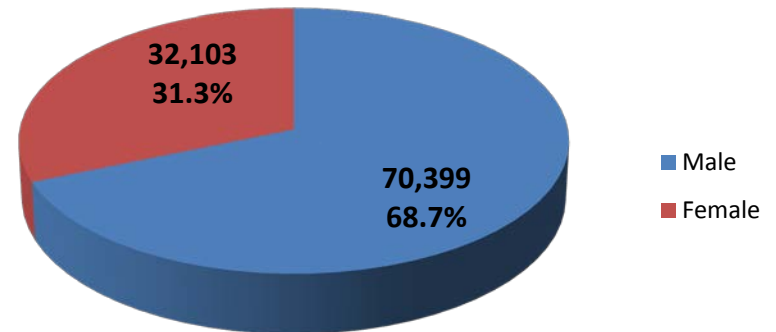


# All Students Compared to Students with Disabilities by Gender

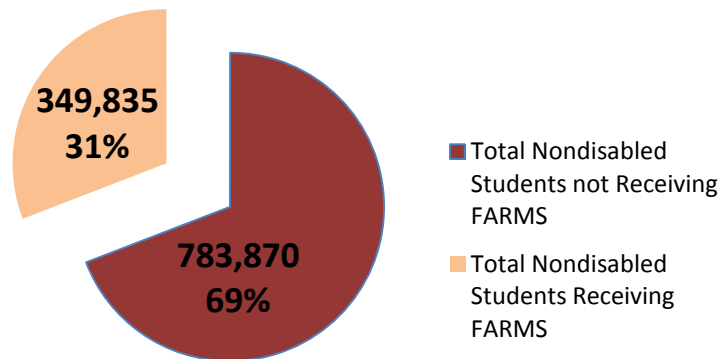

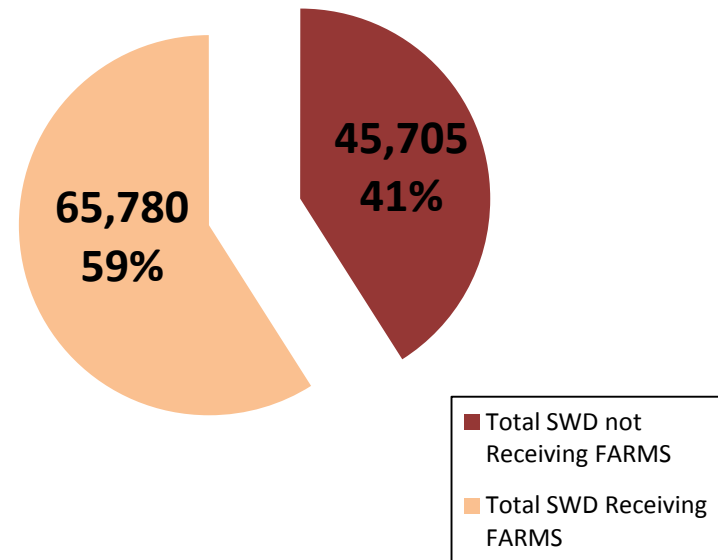


# Number of Students Who Receive Free and Reduced Meals (FARMS)
